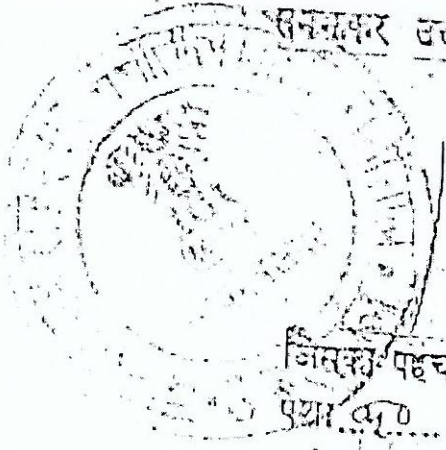

AND IT IS HEREBY DECLARED that the charitable objects here in above mentioned shall not be limited or restricted to any particular religion community caste or creed;
